Candidates must have senior management/leadership experience, ideally from within the sports sector, to be considered for this senior position. The successful candidate will be a supportive and motivational leader and manager who can implement and lead on change and play a key part in ensuring the delivery of the Huddersfield Town Foundation's strategy.

Applicants must be educated to Level 3 (A Level or equivalent) or higher with a strong track record in leading and managing both projects and people. Candidates must have a collaborative approach to working with others, the ability to work calmly and to meet deadlines, and be passionate about making a difference through the power of sport, physical activity, and learning.
